## How We Use Your Information

#### How We Protect Information You Provide

The Organization uses reasonable and appropriate security measures to protect the information under our control. Although we make good faith efforts to securely store and process information collected by our websites, we cannot guarantee complete security.

We may require you to create and use a password to access our learning management system. Those passwords should be strong to help ensure the security of your account. If we learn of a data security incident that affects your personal information, we may attempt to notify you via email, mail, telephone, or any other means permitted by law so that you can take appropriate protective steps. We may also post a notice if a data security incident occurs.

This privacy policy covers our website. Our website may link to third-party websites. We are not responsible for the content or privacy policies of third-party sites. We encourage you to read the privacy policies and review the practices of all websites you visit.

## **Other Disclosure of Your Information**

Though we make every effort to preserve user privacy, we may need to disclose personal information when we have a good-faith belief that release is appropriate to comply with the law (for example, a lawful subpoena); to protect our rights or property; to protect our donors, artists, and supporters from fraudulent, abusive, or unlawful conduct; or if we reasonably believe that an emergency involving immediate danger of death or serious physical injury to any person requires disclosure of communications or justifies disclosure of records without delay.

In the event that we combine with another entity, or another entity controls us, your information may be shared with that entity. We also share your information with service providers who help us perform general business functions, including the functions described in this privacy policy. Finally, we may ask for your consent to share your information in other ways.

#### About Cookies, IP Addresses, and Log File Data Cookies

A cookie is a piece of data stored on the user's device containing information about the user.

The Organization's sites use cookies for measuring aggregate web statistics, including the number of monthly visitors, number of repeat visitors, most popular webpages, and other information, as well as to facilitate your online visit by maintaining data that you provide. The Organization uses cookies to facilitate your access of the training courses by maintaining data that you provide so that you will not need to resubmit certain information.
